This commitment aims to collectively foster an organizational culture and values of integrity in the performance of our duties, while rejecting patronage systems. We shall avoid any actions that may influence discretionary judgment or decision-making in the discharge of our responsibilities, which could lead to discrimination or unfair practices. Furthermore, we are dedicated to preventing conflicts of interest and strengthening public trust by performing our duties with good governance.
